EXPORT OF BROILER CHICKENS—ANNOUNCEMENT OF SUCCESSFUL TENDERER

Mr. A. B. Douglas (Assiniboia): I have a question for the Minister of Agriculture.

Mr. Douglas (Assiniboia): Can the minister report today on who was the successful bidder on the tenders for a large quantity of broilers for export, which tenders were to have been opened yesterday?

Hon. H. A. Olson (Minister of Agriculture): Yes, Mr. Speaker. The successful bidder was—I am trying to find the exact name.

Mr. Olson: The successful tenderer was a group in the province of Quebec who put together the surplus broilers they had in storage and submitted one tender. If the hon.
