in the local postal strike in Belleville, Ontario, and meet the reasonable request of the employees so that regular service can be restored?

Hon. André Ouellet (Postmaster General): Mr. Speaker, I will look into the matter.

## AGRICULTURE

SUGAR BEETS—REQUEST FOR ALLOCATION TO ATLANTIC AREA

Mr. Fred McCain (Carleton-Charlotte): Mr. Speaker, my question is to the Minister of Agriculture. If there is to be an increase in domestic production of sugar, is consideration being given to an allocation of this production to the Atlantic area?

Hon. E. F. Whelan (Minister of Agriculture): As far as I know, Mr. Speaker, at the present time there is no production of sugar beets in the Atlantic area for commercial use. If there is, we will certainly investigate it. As the Minister of Agriculture for Canadian producers, I will do what I can to help them.
