Mr. Speaker: Order, please. I suggest that the hon. member's question is a representation. It is not a supplementary. The hon. member asked a question on transportation. It may have been a related question, but it was not a supplementary question.

REQUEST FOR ADMISSION TO CANADA OF CHILEAN REFUGEES NOW IN BUENOS AIRES

Mr. Andrew Brewin (Greenwood): Mr. Speaker, may I direct a question to the Secretary of State for External Affairs. Has the minister received representations from the Canadian Council of Churches and the Canadian Catholic Conference in respect of 150 refugees from Chile who are, I believe, at the airport in Buenos Aires in the Argentine and who are seeking to come to Canada. They have been threatened with immediate deportation back to Chile or to their countries of origin. Will the government take urgent steps with a view to permitting as many as possible of these refugees to come to Canada in accordance with the undertaking given by the minister to the House that the government will adopt a humane attitude in such cases?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, on the specific question as to whether I received representations from the Canadian Catholic Conference, I do not know whether in fact I received representations. My department reports, however, that this situation, which was outlined to me in the letter from the hon. member of October 22, is a situation of which they were unaware. Therefore, I asked our office here to get in touch with Buenos Aires, and I am now expecting a report. If, in fact, the situation is as reported, I can assure the hon. gentleman that the Canadian government will apply the humanitarian standards that it has always applied to similar situations.

Mr. Brewin: Mr. Speaker, by way of a supplementary question, may I make a recommendation? Does the minister not appreciate that there is great urgency involved in this case, as these people may be deported and it may be too late to do anything?

Mr. Sharp: Mr. Speaker, as I say, the department had been unaware of this, but as soon as the hon. member's letter was received I had a message sent off to Buenos Aires, to check on the report.

In view of present energy difficulties, can we expect that the government will be accelerating its program of nuclear plants and, in particular, will the first decision, the one in which New Brunswick is interested, be made almost immediately? Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, the proposal, as the hon. member knows, is not only for a nuclear plant but also for a heavy water plant in New Brunswick. I hope that the question of a heavy water plant can be decided by the government before the end of this month.

REQUEST FOR REFERENCE OF COST TO STANDING COMMITTEE—POSSIBLE INTRODUCTION OF AMENDING LEGISLATION

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I should like to address a question to the government House leader.
