## RECALL OF REGENT CHOCOLATE COMPANY PRODUCTS

Has the Department of National Health and Welfare uncovered any recent additional quantities of chocolates produced by the Regent company of Saint-Hyacinthe that are contaminated by Salmonella? If so, is the department ordering the immediate recall of these chocolates?

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, all the chocolate produced by Regent has been recalled and production has stopped.

Mrs. MacInnis (Vancouver Kingsway): For the protection of the public, will the government immediately publish the names of firms and retail outlets selling these chocolates, and the brand names under which they are being sold?

Mr . Lalonde: As I have said, we have published the brand names of those-
