NOISE LEVEL

Question No. 292—**Mr. Herbert:**

Does the government intend to introduce legislation requiring the labelling of all appliances, equipment and vehicles to indicate the decibel output of the item and, if so, will a maximum noise level be established?

Hon. Walter Baker (President of the Privy Council and Minister of National Revenue):

Under the Hazardous Products Act, there is already a maximum allowable noise level of 100 decibels for toy products. Consumer and Corporate Affairs Canada does not plan to introduce legislation requiring the labelling of all appliances, equipment and vehicles to indicate the noise emission of the products, nor does the department intend to establish maximum noise levels for all such products.
