On January 17, 1983, Madam Sauvé, then Speaker, touched on the question of what is appropriate comment in statements by members.

The hon. member who has risen was stopped by me earlier today after I listened for a few minutes, or at least some seconds, and it became clear, at least I thought it was clear, that the hon. member was making a personal attack on another hon. member.

As a consequence, I had to stand and interrupt him.

On January 17, 1983, Madam Sauvé said this: "The time set aside for members' statements should not be used to make personal attacks." She went on and said: "It is clear that personal attacks are not considered to be matters that should be raised."

That is the rule that we have tried to follow in this House. It may well be that that rule has been transgressed, and I might have missed it.

I assure the hon. member that I do listen carefully. If I erred in letting that rule be transgressed at some other

# **BUSINESS OF THE HOUSE**

#### WEEKLY STATEMENT

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, this being Thursday, I would like to ask the government House leader if he could tell the House what business we are to deal with when we come back here on November 19, and possibly that week.

Hon. Harvie Andre (Minister of State and Leader of the Government in the House of Commons): Mr. Speaker, pursuant to an order made today, we will adjourn at the end of this day's business and the House will not be sitting tomorrow, sad as that makes me. I am going to have to find something else to do tomorrow. I do not know what. Next week is the scheduled parliamentary break.

We return on Monday, November 19, at which time I propose to call for a continuation of second reading, hopefully to completion, of Bill C-85, having to do with airports devolution; followed by Bill C-90 which has to do with the extension of the charters of the chartered banks of Canada.

On Tuesday, I would again carry on with Bill C-90 if it has not been completed on Monday; and commence second reading on Bill C-88, which is the establishment of Canada's participation in the European Bank for Reconstruction. Wednesday, again these are subject to changes, but the proposal would be Bill C-76, the Aeronautics Act, and Bill C-92, financial administration, both of which are technical in nature.

Mr. Gauthier: Mr. Speaker, I just thought that if it would make the minister feel better, as government House leader, if tomorrow he wants to come into the House and maybe answer some questions for a change, we would be more than pleased to ask him those questions.
