An Act to revive and continue, for a limited time, the several Acts therein mentioned.

WHEREAS it is expedient to revive and further to continue the Acts Preamble, hereinafter mentioned, which, in consequence of the unexpected termination of the now last Session of the Provincial Parliament, were not continued in the usual manner: Therefore, Her Majesty, by and 5 with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:-

1. The Act of the Parliament of this Province, passed in the Session Acts of Canaheld in the tenth and eleventh years of Her Majesty's Reign, and in-da 10, 11 Via tituled: "An Act to enlarge the powers of the Trinity House of Mon-cap 1. 10 treal, in certain cases where the Public Health of the City may be endangered;" the Act of the Parliament of this Province passed in the fourteenth and fifteenth years of Her Majesty's Reign, intituled: " An Act to incorporate the Grand Division and Subordinate Divisions of the 14, 15 Vic. Order of the Sons of Temperance in Canada West;" the Act of the cap 159. 15 Parliament of the late Province of Lower Canada, passed in the second Acts of L. C., year of the Reign of His late Majesty King George the Fourth, and 2 G. 4, cap 8. intituled: "An Act for better regulating the Common of the Seigneurie of Laprairie de la Madeleine:" the Act of the said Parliament, passed in the same year of the same Reign, and intituled; "An Act to enable 20 the inhabitants of the Seigneurie of La Baie Saint Antoine, commonly ² G. ⁴ can 10. called La Baie du Febvre, to provide for the better regulation of the La Baie St. Common in the said Seigneurie," as amended and extended by the Act of the said Parliament, passed in the fourth year of the same Reign, and intituled: "An Act to authorize the Chairman and Trustees of 25 the Common of the Scigniory of the Baie Saint Antoine, commonly 4 G. 4 cap. 26. called the Baie du Febvre, to terminate certain disputes relating to the limits of the said Common, and for other purposes appertaining to the same;" the Act of the said Parliament, passed in the ninth year of the same Reign, and intituled: "An Act to alter and amend an Act, passed 30 in the sixth year of His Majesty's Reign, intituled: 'An Act to 2 G. 4 cap 32. authorize the inhabitants of the Fief Grosbois, in the County of Saint Fief Grosbois.

Maurice, to make regulations for the common of the said Fief;" and all and every of the said Acts are hereby revived and continued and shall end of Session be in force from the passing of this Act until the first day of January, after 1st Jan.,

35 one thousand eight hundred and sixty-four, and from thence until the 1863. end of the then next ensuing Session of the Provincial Parliament, and no longer; and shall be held to have been in force from the end of the said now last session as then continued, except only in cases where the expiration of any of the said Acts may have been pleaded before 40 the passing of this Act.

2. The Act of the Parliament of this Province, passed in the seventh Acts of Canada 7 Vic. cap. year of Her Majesty's Reign, and intituled: "An Act to repeal an Ordi- 10. nance of Lower Canada, intituled: 'An Ordinance concerning Bankrupts, Bresta and the administration and distribution of their estates and effects,' and to
