

The House proceeded to take into consideration the amendments made by the Legislative Council to the Bill, intituled, "An Act to amend the Act concerning the erection and division of Parishes, and the building and repairing of Churches, Parsonage Houses and Church Yards and Fabrique Meetings, chapter eighteen of the Consolidated Statutes for *Lower Canada*," and the same were read, as follow:—

Page 1, line 25,—Leave out "or Clerk."

Page 1, line 26,—After "held" insert "*primâ facie*."

The said amendments, being read a second time, were agreed to.

*Ordered*, That the Clerk do carry back the Bill to the Legislative Council, and acquaint their Honors that this House hath agreed to their amendments.
