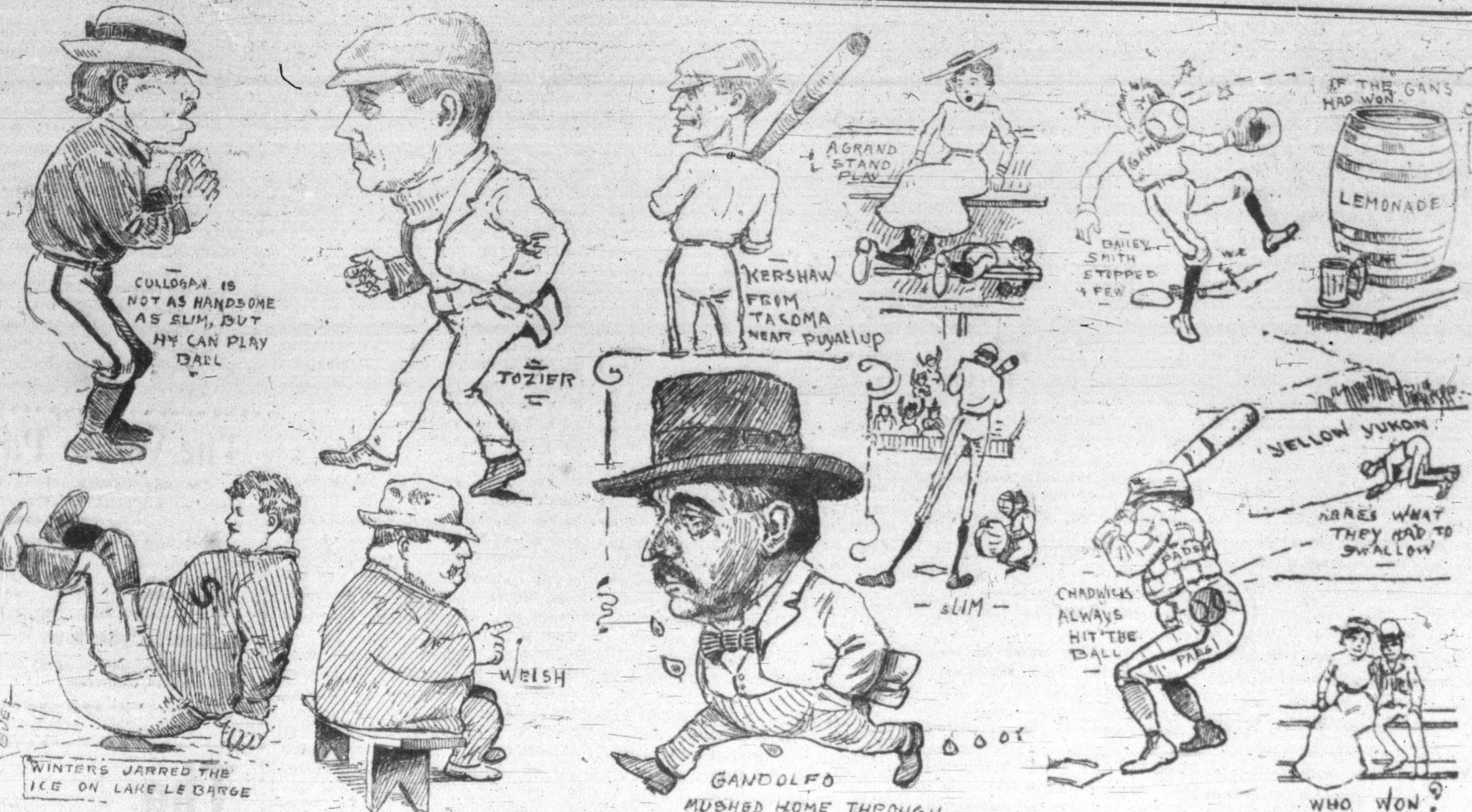
IS SUED FOR \$9,000

An Endorser of a Note Called Upon

La France Claims Conditions Upon Which He Signed Were Not Carried Out.

The case of the Bank of British North America vs La France which was begun before Mr. Justice Craig and a jury yesterday was being continued this forenoon with a strong probability of its being completed and given to the jury before the end of the day's session. The action of the bank is to recover on a note of \$9000 signed by Charles Bossuyt and endorsed by La France, the latter one of the wealthiest and best known cattle men in Manitoba with headquarters at Winnipeg. The defendant admits signing the paper and as all that is necessary for the plaintiff is to prove the note it is up to the defendant to show cause why he should not pay it, the onus of proof being upon him.

From the testimony adduced at the hearing yesterday and today it appears that for a number of years La France has been supplying the Dawson market with meat, his dealings being largely through Bossuyt who is one of the pioneers in that line. At different times the latter had a very extensive credit with La France and also with the bank, the present plaintiff. On October 12, 1901, the defendant arrived in the city with a cargo of beef cattle and hogs which Bossuyt was very desirous of securing. He at that time was indebted to the bank in a considerable sum and an arrangement was made by which the bank advanced sufficient funds to pay for the consignment of live stock afterward securing themselves by taking a chattel mortgage from Bossuyt on everything he owned in the sum of \$41,500; the date being November 14 of the same year and the conditions \$10,000 to be paid in thirty days and the balance on demand, interest to be at the rate of eighteen per cent. per annum. Since the beginning of the suit, however, the interest at that rate has been abandoned, changed to the legal rate of seven per cent. per annum. The cattle were paid for at the rate

COPPING'S BODY FOUND.

On Drift Wood Below Ogilvie

Identity Fully Established by a Ring Bearing Unfortunate Man's Initials.

A report which came to Dawson last night of the finding yesterday of W. B. Copping's body on a pile of drift wood two miles below Ogilvie was confirmed this morning by a telegram received by Major Cuthbert from Sergeant Ed Smith in charge of the police station at Ogilvie. The telegram describes the body as being that of a man 5 feet, 10 inches in height, front of head bald, dressed in black sweaters, blue overalls and hip boots. On one of the fingers was a ring bearing the letters W. B. C. The wire says nothing about the condition of the body or the circumstances of its being found. Copping was drowned on May 5th in the Yukon river about 28 miles above Stewart and approximately from 60 to 65 miles above where the body was found. It was in the water 35 days. Major Cuthbert sent a wire to Ogilvie this morning instructing that the body be brought to Dawson at once. It will probably arrive this evening or tonight.
