6. Number of tax payers who have paid this assessment.

1. How many survivors there are of the First Canadian Division.

2. How many of those survivors have come to Canada on furlough, since 17th December, 1917.

Ordered, That there be laid before this House, a Return showing:-

- 1. How many farmers have enlisted in the Canadian Expeditionary Forces.
- 2. How many farmers have enlisted from each Province in the Dominion.
- 3. How many farmers have enlisted from the County of Durham, Ontario.

On motion of Mr. McKenzie, for Mr. Chisholm, seconded by Mr. Murphy,

Ordered, That there be laid before this House, a copy of all accounts, vouchers, receipts, telegrams, particulars and correspondence of all kinds in any way referring to the expenditure of money by this Government at Friar Siding, under the foremanship of P. Doucette, during the months of October, November and December, 1917.

Ordered, That there be laid before this House, a copy of all letters, telegrams, vouchers, accounts and all documents in any way referring to the expenditure of money in repairs on the Margaree Breakwater, by the Department of Public Works, during the years 1916-17 and 1917-18.

On motion of Mr. Gauthier, for Mr. Brouillard, seconded by Mr. Archambault, Ordered, That there be laid before this House, a copy of all letters, telegrams and correspondence generally exchanged between the Government and Mr. Justice Duff, Central Appeal Judge, during the last election campaign concerning the application and the administration of the Military Service Act in conjunction with the Order in Council passed on 3rd December, 1917.

On motion of Mr. Cockshutt, for Mr. Stevens, seconded by Mr. Davidson, Ordered, That there be laid before this House, a Return giving a copy of all letters, telegrams, vouchers, evidence and all other documents, relating to an inquiry into the wages, conditions of labour, etc., of the shipbuilding industry in British Columbia and conducted by a Commission of which Honourable Justice Murphy was chairman; also, copy of findings of said Commission.
