Mr. Trudeau: That is another complex question, Mr. Speaker. INQUIRY AS TO INITIATION OF CONTROL LEGISLATION

Mr. David Lewis (York South): Mr. Speaker. I should like to address a question to the Acting Minister of Energy, Mines and Resources during the minister's illness. In view of further emphasis on the need to make an organized beginning in the control of pollution, what progress has been made by the Department of Energy, Mines and Resources and, as far as the minister knows, the department of health and welfare in getting pollution control legislation initiated?

Hon. Jean-Luc Pepin (Acting Minister of Energy, Mines and Resources): Mr. Speaker, we are looking forward to the introduction of the Canada waters act. Last week I spent two days in Victoria meeting with the provincial ministers and our respective officials responsible for water. We made some progress at that time in the discussion of approaches. More specifically, the multi-jurisdictional approach to pollution problems is getting more and more accepted by the provinces. The regional approach is also becoming more and more advocated in the speech from the throne.

> Mr. Pepin: No, Mr. Speaker. This is still one of the subjects that we are discussing with the provinces. My hon. friend is quite aware that not all provinces agree with us or among themselves on these subjects. I agree it is a slow process, but we have been working for a number of months toward building a consensus on these matters, and I think we have made some progress. By the time we bring in the water act we will be much closer, I think, to a consensus on these questions than would have been the case had we introduced the act last year.

> Mr. Lewis: Mr. Speaker, I have another question arising out of the minister's answer. Would he be good enough to inform the house whether these discussions are being carried on intermittently between ministers, or is there a permanent committee of officials representing federal and provincial governments that is entering into a discussion of all these areas?

> Mr. Pepin: Mr. Speaker, discussions have obviously been going on among ministers on these subjects. The federal interdepartmental committees have also been at work here. The co-ordination between federal and provincial governments in this matter is generally undertaken through the council of resource ministers.
