I would ask him whether, in view of the fact that veteran sealers believe the opening date for the seal harvest in the Gulf of St. Lawrence, set for

March 18, is too late, and want the date set ahead to March 12, the government has given any consideration to changing to the earlier date.

Hon. Donald C. Jamieson (Minister of Defence Production): I would have to take the question as notice and give a reply as soon as possible.

Mr. Carter: A supplementary question to the Minister of Industry, Trade and Commerce. In view of the disastrous condition of last year's fur seal market, due to the tremendous volume of adverse publicity about the annual harvest, can the minister say whether market conditions are expected to improve this year?
