## INTENTION OF RAILWAYS TO ABANDON CERTAIN BRANCH LINES

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, my question is for the Minister of Transport. Several years ago the railways presented the country with a list of lines that they intended to abandon. The government at that time stepped in and guaranteed that these lines would be operated until January 1, 1975. Has the minister authorized these lines to be abandoned at this time or are the railways proceeding on their own initiative?

Hon. Jean Marchand (Minister of Transport): No, Mr. Speaker. The only policy at this time is that all these branch lines are frozen. We do not know exactly what is going to happen in the future.

Mr. Korchinski: In view of the fact that some of these lines are operational and rail liners are going through on these lines, why is it that boxcars are left sitting on sidings and carloads of fertilizer, lumber and oil are not brought in by rail but by truck transport?

Mr. Marchand (Langelier): Mr. Speaker, I think we will have a perfect opportunity on Wednesday next, when I will meet in a national conference the railways, the shippers, all those who are users of railways and the truckers, to get to know exactly what is happening and to ask the railways what we want to ask them. We have invited the chairman of the Standing Committee on Transport and Communications and he will surely attend the meeting.

# REQUEST THAT CONTROL OF RAILWAY AND AIR TRANSPORT, HARBOURS BOARD AND MARITIME COMMISSION BE RETURNED TO DEPARTMENT

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, my question is for the Minister of Transport. As the minister has clearly indicated in recent speeches that much of the difficulty in transportation matters today is caused by lack of control over these matters by the government, is the minister giving consideration to bringing back into his department the Board of Transport Commissioners, the Air Transport Board, the National Harbours Board and the Canadian Maritime Commission, and by so doing once again give the government the control it needs over these important matters, thereby greatly improving transportation of Canadian goods?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, I thank the hon. gentleman for the question. I think I have already partly answered it by saying that I hope shortly to be in a position to produce a policy paper for the cabinet on the revisions I think should be made in the department. At that time I will be happy to discuss it with members of the House.
