1. What is the estimate of the cost involved in providing old age security to those in the 64 year age group in 1976?

2. What would be the estimate to reduce the eligibility age by one year in each succeeding year to lower it to age 60?

3. Is there an estimate of what amount of social assistance is presently being received by persons in each of the age groups from 60 to 64 and, if so, what is it?

Hon. Marc Lalonde (Minister of National Health and Welfare): 1. On the assumption that the January 1976 OAS rate remains constant in 1976, and based on Statistics Canada population projections, the estimated additional cost in 1976 would be \$259.6 million dollars.

Note: The Guaranteed Income Supplement is not included in this estimate.

2. Under the same assumption as that made in the answer to part 1, the estimated additional cost would be:
