I am trying to be serious. In 1977, for example, there was an outflow from Canada of approximately \$240 million in the form of dividends and interest because of foreign ownership and foreign equity. In 1978 that figure increased to over \$2 billion. I say again \$2 billion. So we have a government across the way that is borrowing more and more money to pay off all these debts. It is allowing more and more foreign ownership in this country. It intends to privatize more and more firms and turn over more and more control of our economy to private and foreign hands. We see this as having a negative effect on the economy.

We in this party say that we need a real change in Canada. We need an economic and an industrial strategy to start doing our own things. We need to take control of our economy by processing our own goods from our own raw materials. We need to start to manufacture the things we are using. We need that industrial strategy. Unless we have it we will have more of the same thing. This means a sagging dollar, more and more borrowing, more and more foreign ownership and control and more and more increases in the bank rate.

I suggest that we do nationally what is being done in the province of Saskatchewan, that is, to plan the economy, to take control of resources, to develop them for ourselves, to keep the profits from those resources at home and to keep the jobs in processing those resources in the hands of Canadians instead of having raw materials processed elsewhere. The province of Quebec is devising an economic policy based on cheap hydro power from the James Bay plants that are coming onstream. Even before the days of James Bay, hydro rates in Quebec for industry were 50 per cent cheaper than they were in Ontario and 100 per cent cheaper than in many parts of the United States.

May I call it five o'clock, Mr. Speaker?
