Dr. Rafael Caldera, former President of Venezuela and presently President of the Interparliamentary Council of the Interparliamentary Union, has brought to my attention the fact that Mr. Javier Ruperez, a member of the Lower Spanish House and Foreign Affairs Secretary of the Union of the Democratic Centre, has been kidnapped by terrorists. Therefore, I move, seconded by the hon. member for Saint-Denis (Mr. Prud'homme):

That this House views with sadness and concern the kidnapping of Mr. Javier Ruperez, a member of the Lower Spanish House and Foreign Affairs Secretary of the Union of the Democratic Centre, a staunch defender of human rights, and expresses its earnest hope for his immediate release.
