**Mr. Mike Cassidy (for Mr. Orlikow)** moved:

Motion No. 8

That Bill C-129 be amended in Clause 10 by striking out line 26 at page 7 and substituting therefor:

"the Corporation and the Commissioner of Official Languages shall include in the annual report a review of the performance of Air Canada in respect of attaining the goals and objectives of the Official Languages Act."

He said: Mr. Speaker, I would suggest that we go immediately to a vote on Motion No. 8. Perhaps then we can debate Motion No. 9. I believe that would have the support of my friends in the Liberal Party.

Motion No. 9

That Bill C-129 be amended in Clause 11 by adding immediately after line 4 at page 8 the following:

"the Corporation assumes all assets and all liabilities of the Corporation held immediately prior to the day on which the Corporation becomes a corporation to which the Canada Business Act applied."

He said: Mr. Speaker, while we would like to prolong the debate on this we are aware of the agricultural bills and I will be the only speaker for my Party on this motion.

I may add that the motion on which we just voted was about official languages, and its purpose was to ensure that the Commissioner of Official Languages will continue to monitor the performance of Air Canada with respect to the objectives of the Official Languages Act. Unfortunately, the Government rejected this motion which simply ensured that the Commissioner's annual report would contain an assessment of Air Canada's performance in this respect.
