This pier is to provide accommodation for the St. Lawrence Sugar Refinery and other industries in Maisonneuve which are now handling their business over the low level Sutherland pier, which latter pier is to be hoped will be raised to high level in future. Before work, however, can be done on the raising of this pier, it is necessary that some other location be provided upon which these industries can handle their business, hence the provision of a new pier in this connection.

Hon. Mr. WILLOUGHBY: I am quite satisfied.

Hon. Sir JAMES LOUGHEED: Will my honourable friend say what supervision is exercised over the carrying out of the works in question by the Government of the Dominion?

Hon. Mr. DANDURAND: It is under the Department of Marine and Fisheries.

Hon. Sir JAMES LOUGHEED: Are estimates submitted to the Government, and are the works approved by the Government?

75,000 Hon. Mr. DANDURAND: Yes.

> Hon. Sir JAMES LOUGHEED: And are they carried out under the supervision of the Government?

Hon. Mr. CASGRAIN: Everything is done under Government specifications.

Hon. Sir JAMES LOUGHEED: To what extent does the Government make inquiry into the manner of expenditure?

Hon. Mr. DANDURAND: Those estimates are received in a general way, indicating what works they will cover, but when they are prepared to do some extension or other work under those estimates they must obtain the approval of the Minister of Marine and Fisheries, who submits the estimates and obtains an Order in Council sanctioning the expenditure.

300,000 Hon. Sir JAMES LOUGHEED: Is there any rule that the work is to be let by tender, or what is the method?

Hon. Mr. DANDURAND: There are works 50,000 which would be carried on by tender and contract, but there are very many others that are done by day work.

> Hon. Mr. ROCHE: Are the charges on shipping for wharfage and storage very heavy, or not?

> Hon. Mr. DANDURAND: I do not think I have the data.

Hon. Mr. CASGRAIN: They are sufficient to pay the interest on all the bonds, and for all the work, and leave a surplus. It is not like that in any other port that we know.

Hon. Mr. FOWLER: How will it be in the case of the \$10,000,000, because that will add, for interest alone, some half million dollars a year, and then a sinking fund will have to be
