BILL S-2

An Act to implement conventions between Canada and Finland, Canada and the Czech and Slovak Federal Republic and Canada and the United Mexican States for the avoidance of double taxation with respect to income tax and the prevention of fiscal evasion and a convention between Canada and the United Mexican States for the exchange of information with respect to taxes

First reading, May 23, 1991. Second reading and referral to Foreign Affairs Committee, May 30. Report from Committee (without amendment), June 20. Third reading, June 21. Passed by the Commons, February 25, 1992. Royal Assent, February 28. *Chapter 3, 1992.*

BILL S-8

An Act to regulate the manufacture and importation of motor vehicles and motor vehicle equipment to reduce the risk of death, injury and damage to property and the environment

First reading, March 17, 1992. Second reading and referral to Transport and Communications Committee, March 30. Withdrawn from the said Committee and referred to Legal and Constitutional Affairs Committee, May 7. Report from Committee (with four amendments), June 17. Adoption of Report and third reading, June 19. Message from Commons with two amendments, March 29, 1993. Referred to Transport and Communications Committee, March 30. Report from Committee agreeing with Commons' amendments without amendment, April 29. Adoption of Report, May 3. Royal Assent, May 6. *Chapter 16, 1993.*

BILL S-11

An Act to amend the Airport Transfer (Miscellaneous Matters) Act

First reading, May 22, 1992. Second reading and referral to Transport and Communications Committee, June 3. Report from Committee (without amendment), June 15. Third reading, June 16. Passed by the Commons, June 19. Royal Assent, June 23. *Chapter 42, 1992.*

BILL S-17

An Act to amend the Copyright Act, the Industrial Design Act, the Integrated Circuit Topography Act, the Patent Act, the Trade-marks Act and other Acts in consequence thereof

First reading, December 8, 1992. Second reading and referral to Legal and Constitutional Affairs Committee, December 14. Report from Committee (with certain amendments), March 1, 1993. Adoption of Report, March 2. Third reading, March 3. Passed by the Commons, April 26. Royal Assent, May 6. *Chapter 15, 1993.*

BILL S-18

An Act to amend the Currency Act

First reading, December 14, 1992. Bill ruled out of order and withdrawn, April 28, 1993.

An Act to amend the Tobacco Restraint Act and to amend the Tobacco Products Control Act (Senator Haidasz, P.C.)
