PROTECTION AGAINST OIL SPILL FROM TANKER  
"KURDISTAN"—MOTION UNDER S.O. 43

**Mr. J. M. Forrestall (Dartmouth-Halifax East):** Mr. Speaker, I rise under the usual Standing Order respecting a matter of considerable urgency to the east coast of Canada.

The continuing presence of the stern section of the oil tanker *Kurdistan* off the Nova Scotia coast in the Gulf of St. Lawrence, coupled with continued delays in making final disposition plans, and in light of the apparent dangers posed by this continued delay in the final disposition process, I move, seconded by the hon. member for Esquimalt-Saanich (Mr. Munro):

That the responsible authorities take the earliest decision possible to resolve the situation either by removal from coastal areas for sinking purposes, or to arrange for its towing into a suitable and safe port for the discharge of the residual oil in the tanker.

PROTEST AGAINST REMOVAL OF ABORTION CLINIC FROM  
WINNIPEG—MOTION UNDER S.O. 43

That the Minister of Justice consult today with his provincial counterpart to discuss concrete proposals that would prevent an American interest from investing over \$100,000 in an abortion clinic which, in effect, will offer abortions on demand. Such a clinic would be both a violation of the right to life and the Criminal Code of Canada.
