the Italians. THE CATTLE TRADE. London, March 13.-In the House of Commons, Right Hon. Walter Long, President of the Board of Agriculture, in reply to interrogations, said that cases of contagious pleuro-pneumonia had been found in cattle imported from the United States, and sixteen imported from Canada since October, 1892. He had no doubt that the disease was specifically infectious, though the degree of infection was relatively small. Whatever view the Canadian and United States authorities might take, could only say that it had been conclusively proved here that the disease

was infectious. The House passed the third reading of the Liverpool Cattle Market Bill, abandoning the old building for new one which is to be constructed near the docks. Mr. T. P. O'Connor, member for the Scotland division of Liverpool, objected to the change on the ground that the location of new site of the market would favor

American against Irish cattle. APPEAL OF THE GREGORIAN

CLERGY. London, March 13 .- It is said that some days before the massacre at Oorfa the Armenians were warned that it was impending, but the officials prevented them from leaving the town. During the suspense the Gregorian clergy secretly sent a letter to Aintab, whence it was forwarded to Europe. The Archpriest Stephen and four other priests were subsequently slain before the altar while celebrating the Eucharist. The letter contains messages to the Sultan and to the Gregorians' Moslem fellow-countrymen, and reproaches their European brethren for standing by, watching the bloody work. It also contains the following: "To the Christians of the United States of America we say farewell. We have been strenuously opposed to your mission work among us, but these bloody days have shown that some of our Protestant brethren have been staunch defenders of our honor and our faith. You, at least, know that our crime in the eyes of the Turk has been that we adopted the civilization you commended to us. Behold, now the missions and schools which you planted among us at the cost of many millions of dollars and hundreds of precious lives. They are in ruins, and the Turk is planning to rid himself of the missionaries and teachers by leaving them nobody among whom to labor.

IN RE PRIVATEERING. London, March 13.-In the House of

Commons Thomas Gibson Bowles (Conservative) asked if the Government's attention had been called to statements in the Spanish press that in the event of war with the United States Spain would fit out privateers to prey on American commerce, she not being a party in the declaration of Paris of 1856.

Right Hon. A. J. Balfour said that in view of the fact that there had been no privateers fitted out in any war since 1856, even by the powers that had not acceded to the declaration if Paris, and in view also of the fact that the principle of a neutral flag received general acceptance, he doubted that Spain or any other country would adopt the measures suggested.

Mr. Balfour held that there was a general acceptance of the Paris declaration by all the powers, though it was embodied in a treaty.

The Under Secretary for the War Office, Mr. St. John Broderick, said the War Office had no news of any English militia officers having volun-teered their services to Spain in case of war with the United States. Any officer taking such a step would be liable to the penalties of the Foreign Enlistment Act.

THE G. O. M.

London, March 13 .- The Daily News says that Mr. Gladstone has declined to introduce a deputation to Lerd Salisbury to urge the establishment of a national fund, under Government patronage, for the relief of the Armenians, which he was requested to do by the Anglo-Armenian Relief Society.

Mr. Gladstone bases his declination on sprounds of physical infantian and the street of the st grounds of physical infirmity and abtinence from public affairs. The paper adds that in conversation with Francis Stevenson, M.P., the chairman of the Anglo-Armenian Association, Mr. Gladstone said he greatly regretted the acceptance of Turkish honors by Prince Lobanoff, the Russian Foreign Min-ister, and M. Nelidoff, the Russian ambassador to Turkey. The acceptance of these honors, coupled with Russia's recent attitude on the Armenian question must be held to make Russia morally answerable for future outrages. He advised that a communication addressed to Lord Salisbury would be preferable to a deputation. He did not see any reasonable objection to give the patronage of a national fund for the relief of the Ar-

### BRITAIN ABROAD.

Foreign Policy Criticised by Sir William Harcourt-It Is Neither Glorious

Nor Economical. London, March 13 .- Sir William Vernon Harcourt, the Parliamentary leader of the Opposition, made a political speech Wednesday at Boscombe, in which he dwelt in grave terms upon the conditions of British foreign relations. He declared that ever since the present Government had been in office, England had been in the midst of a hurricane of foreign complication, blowing from every quarter. Their foreign policy had been neither glorious nor economical, witness Armenia and the budget estimates. The splendid isolation of which the Government was so proud was the out-come of jingoism. The situation abroad, Sir William continued, had never been so grave within the memory of living men. The Armenian difficulty, he said, was a legacy of Beaconsfield statesmanship. Venezuela, he pointed out, was the gravest difficulty which menaced us. He regretted that the blue book had not been published in December in place of Lord Salis-bury's dispatches. No word should esthat in view of the restlessness of the cape his lips, however, to embarrass the Government in obtaining a peace-

### LOOKS LIKE MURDER.

Collector Brown, of the Soo, Had Two Bullets in His Heart.

Sault Ste. Marie, March 13.-It is now believed that Frank W. Brown, collec tor of taxes for the town of Sault Ste. Marie, Ont., who was found dead in his office last week, did not commit suicide, but was the victim of foul play. A strange feature was that two bullets had pierced the heart, and that, in all, three shots were fired. It was supposed that he was alone when he met his fate, but the authorities now think that he met death by a revolver in the hands of another, although, when he was found, the gun was tightly clinched in his right hand. Brown was a sober, industrious man and no motive can be assigned for kill-

# DIED SAVING A DOG.

Carpenter Aronson Rescued His Pet, but

Fell Upon the Track. New York, March 13.-Nicholas Aronson, 54 years old, who lived at Cary avenue and Duncan street, Port Richmend, S. I., was run over and killed at 6:30 o'clock yesterday morning by a Staten Island rapid transit train while trying to save his dog from be-

ing killed. Arcnson was a carpenter in the Star in shipyard at Port Richmond. started out from his home at 6 o'clock and whistled to his dog, an ordinary setter, to follow him. The dog ran on ahead. At the Starin crossing train No. 3 was going west. The dog got on the track directly in front of the en-

gine stood there.

Aronson called to the dog, but seemed to be paralyzed with fright. Aronson then made a dash for the dog, and seizing it threw it safely off the track. Aronson slipped, fell directly on the track, and the engine struck him and threw him from the track. Engineer Donnell and Conductor Brandt, who were in charge of the train, which was brought to a standstill, went to Aronson's assistance, and found him badly crushed about the head and body. # MUST PAY THE POLICY.

An Agent's Note Good for the Premium ot an Insurance Risk.

Toronto, March 13.—Chief Justice Meredith's judgment against the London and Lancashire Life Insurance Company for \$5,000 each on two policies on the life of James Flemming, of Barrie, who died about a year ago, decides an important point for insurance companies. There is a clause in policies, stating that notes will not be accepted in lieu of cash for premiums. The company's agent took a note from Mr. Flemming on the policy, and after deducting his commission forwarded a personal note to the company, which it accepted.

Before Mr. Flemming's note fell due he died, and the company resisted payment on the strength of the clause regarding notes. By the decision of the court, however, the acceptance of the agent's note releases this clause and the company is held liable for acts of their agents.

Mr. Marter Takes a Tilt at the Ontario License Act.

Toronto, March 13 .- In the Public Accounts Committee yesterday, Dr. Chamberlain admitted that he had charged in his expenses for an accident insurance policy.
