# BRITISH PARLIAMENT OPENS; HISTORIC SESSION OUTLINED BY SPEECH FROM THRONE

Government To Bring In Measures Giving Home Rule to the Irish, Disestablishing the Church in Wales and Amending the Franchise Law.

### NO REFERENCE TO GERMANY OR TO LORD HALDANE'S VISIT

Royal Address Proves Colorless and a Disappointment to Large and Brilliant Assemblage-King and Queen Lustily Cheered in Street.

[Canadian Press.]

London, Feb. 14.—The second session of the second Parliament of King George's reign was opened today by King George in person, with all the timehonored picturesque eeremony which always marks such occasions. No speech from the throne has for many years been awaited with such absorbing public interest, and the King himself showed that he realized the momentousness of the occasion by the emphasis he laid on the more salient clauses of his address while he was speaking.

A COLORLESS SPEECH.

Blank disappointment, however, was easily read in the faces of his hearers over the colorlessness of the King's references to the historic legislation mapped out by the Government.

The speech was a short one. In referring to the measures to be brought before Parliament, the King said:

"A measure for the better government of Ireland will be submitted to you "A bill will be laid before you to terminate the establishment of the Church in Wales, and make provision for its temporalities.

"Proposals will be brought forward for the amendment of the law with respect to the franchise and the registration of electors."

NO REFERENCE TO GERMANY.

The King in his speech made no mention of British relations with Germany, and did not allude in any way to Viscount Haldane's recent trip to Berlin, about which there has been so much speculation.

The most interesting reference to foreign affairs was the clause in his address relating to China, when he said:

"I trust that the crisis in China may soon be terminated satisfactorily the establishment of a stable form of Government conforming with the views of the Chinese people. My Government will continue to observe an attitude of strict non-intervention, while taking all the necessary steps to protect British life and property. I fully recognize that the leaders on both sides in Chinahave shown every desire to safeguard the lives and interests of foreigners resi-

#### TRAVELLED IN STATE.

The King and Queen travelled in state to the House of Parliament as Westminster, the procession consisting of the old stage coach with eight cream ponies, in which King George and Queen Mary were seated, preceded by five state earriages conveying the officers of the household. An escort of cavalry brought up the rear.

## Household Narrowly Escaped Asphyxiation.

When the family retired last night, the large coal stove was filled up, but nothing amiss was noticed. During the night Miss Anderson awakened in a suffocating condition. She got out of bed, but collapsed. Later she managed to make her way to a door, which she pushed open a little, allowing some fresh air to come in from the back portion of the house,

She was unable to move after this, but the fresh air coming into the room indoubtedly saved the lives of the three women.

This morning the neighbors, seeing no stir about the house, investigated and found them still stuified from the effects of the gas. The house was thrown open and a physician summoned. After considerable effort all three were revived. They are very ill from the effects of the poisoning, and

The Facts.

"We received a message stating that Tom roomed in a large boardinghouse," said Mr. Logan. "As is the ease in many places, the gas is turned off at certain hours. The people in the house think that he fell asleep with the gas burning. At a certain hour it was turned off, and coming on later, suffocated him. I had an experience of a similar nature once myself, and can readily understand the explanation. There was no reason for suicide in the least. He was not hard up for funds. Last week he was sent \$50 interest on some money left him. The dispatch we received is emphatic in stating that he was not a suicide,"

His parents died when he was quite young, and he was raised by his grandfather, the late William Hodgins, of Birr. # PLACED UNDER ARREST Warrants Served On Prominent Union Men In Chicago, New York, Detroit and Other Cities Following Finding of Alleged Dynamite Conspiracy Investigation at Indianapolis.

[Canadian Press.] Indianapolis, Ind., Feb. 14.—Arrests ruiter. in the dynamite conspiracy cases began today, and soon many of the fifty or more defendants scattered in variate Syracuse, N. Y., and Edward Clark ous parts of the country were taken and Ernest Basey, also labor workers,

Among the first arrested was Frank M. Ryan, president of the International Association of Bridge and Structural Ironworkers. He was taken in Indianapolis, where the ironworkers' international headquarters are located, and from which J. J. McNamara, the convicted dynamiter, was arrested last

Reports from many cities show the Government's intention to arrest all the men at one time,

Agents Indicted. Eleven business agents of the iron-vorkers, four or five officials and some nembers of the executive board, who are charged with knowing what Mc-Namara did with money used to buy explosives, are among those indicted. Spurgeon H. Meadows, business agent of the District Council of the International Brotherhood of Carpenters and Joiners, was also arrested in Indianapolis. He represents one of the three labor unions alleged to be impli-cated in the conspiracy. The officials of the other union represented is E. E. Dowd, of the Machinists' Union, under arrest at Rochester, N. Y.

Frank C. Webb, a former member of the ironworkers' executive board, who was arrested in New York, figures prominently in Ortic McManigal's confession. Webb is charged with meeting McManigal, and showing him where to do "jobs" in Hobeken and Jersey City, N. J.

for lighting the streets last year. According to the figures submitted by Engineer Glaubitz, it will be necessary to use 600 horsepower to supply the light on every post, together with the ornamental system that will be constructed on Dundas and Rich-

Whew! Listen to This! If the same rate is preserved, the city will this year pay about \$67,000 That would wipe out the \$35,000 surplus handed to the present council by last year's aldermer The up-keep will be proportionate to the horsepower used

It is understood, however, that the water commissioners will not ask this large sum of money for lighting the streets. They claim that at \$30,000 a year under existing circumstances, the city did not receive a bad bargain at all, but they will not say that the council will have to pay up in the

same proportion for extensions. While the statement is not authoritative, The Advertiser was informed that \$45,000 would be the annual charge for the new scheme. Whether or not this will be satisfactory to the aldermen is not known, but it is thought that it will be.
