CONVENTION BETWEEN CANADA AND
UNITED STATES**

Hon. W. E. Harris (for the Minister of Fisheries) moved that the house go into committee at the next sitting to consider the following resolution, which has been recommended to the house by His Excellency:

That it is expedient to introduce a measure to implement a convention between Canada and the United States of America for the protection, preservation and extension of the sockeye salmon fisheries in the Fraser river system, signed at Washington on the 26th day of May, 1930, and a protocol thereto signed at Ottawa on the 28th day of December, 1956, and for carrying out Canada's obligations under the said convention and protocol.

SCANDINAVIAN AIRLINES SERVICE, WINNIPEG

Motion No. 8—Mr. Zaplitny:

For a copy of all correspondence, telegrams, memoranda and other documents exchanged between the government and Scandinavian Airlines, also between the government and the council of the city of Winnipeg, since January 1, 1956, related to the request of the said air line for permission to provide air passenger service at Winnipeg, Manitoba.

Hon. George C. Marler (Minister of Transport): Mr. Speaker, I should inform the house that there has not been, since January 1, 1956, any request of the Scandinavian Airlines for permission to provide air passenger service at Winnipeg, Manitoba, and in consequence there is no correspondence between the government and Scandinavian Airlines with regard to such a request. There was an exchange of letters between the mayor of the city of Winnipeg and myself as Minister of Transport which has already been made public. I shall be glad to table that correspondence but that is all I am able to give the hon. gentleman.

Mr. Zaplitny: May I point out to the minister that the request does not relate to January 1, 1956. Only the correspondence relates to that date. The request can be as of any date.

Mr. Marler: Well, Mr. Speaker, there has never been a request for permission to provide air passenger service at Winnipeg, so the date is not material.

Mr. Speaker: Is it the pleasure of the house to adopt the motion subject to the remarks of the Minister of Transport?
