NATIONAL DEFENCE—LAYOFFS AT DOCKYARDS

Question No. 2,583—Mr. Munro (Esquimalt-Saanich):

- 1. How many casual employees in ship repair at HMC Dockyard (a) were laid off (b) left their employment voluntarily between March 26 and July 2, 1973 in (i) Esquimalt (ii) Halifax?
- 2. Have any of these employees benefitted or will they benefit from the retroactive pay rates set forth in the new collective agreement covering ship repair employees signed on July 18 in Ottawa with the Treasury Board and (a) if so, how many (b) if not, what explanation is offered for refusing to pay these employees at the new rates?
- 3. How many persons referred to in Part 1(a) and (b) were re-hired during the period March 26 and July 2 in (i) Esquimalt (ii) Halifax and were they paid eventually at the retroactive rates once the collective agreement already mentioned was concluded?

The itinerary included the following cities: 18-20 July, Ottawa and Toronto; 21 July, Niagara Falls (U.S.A.); 21-24 July, Calgary; 24-25 July, Vancouver; 25-26 July, Yellowknife; 26-28 July, Quebec City; 28-31 July, Montreal & Collège Militaire Royal de Saint-Jean; 31 July, Bagotville; 1 August, Departed Montreal for Azores.

PROPOSED OLYMPIC VILLAGE, MONTREAL

Question No. 2,604-Mr. Stackhouse:

- 1. (a) How much money has been expended for funding the proposed Olympic Village at Montreal (b) how much has been budgeted for future expenditures for this project?
- 2. How much has been paid toward the salary of the Olympic Commissioner?
- 3. How many government employees have been or will be seconded to COJO ?
- 4. (a) How much has been paid toward the salaries of government employees, if any, seconded to COJO (b) how much has been budgeted for anticipated future service by federal employees so seconded?
- Hon. C. M. Drury (President of Treasury Board): 1. (a) None. (b) If the City of Montreal wishes to avail itself of the provisions of the National Housing Act, it is hoped that it may be accommodated within the scope of the existing NHA program and CHMC budgetary capacity for the period for which the request is received.
- 2. \$35,880 have been paid for the period from July, 1972 when the Commissioner-General joined COJO, to August 24, 1973.
- 3. No employee of the federal government other than Mr. C.O.R. Rousseau has yet been seconded to COJO. Approximately 25 man-years may be seconded for the period 1973 to 1976.
- 4. (a) Nothing other than the Commissioner-General's salary as noted in 2 above. (b) Seconded personnel will be provided under normal program funding. Total expenditure has been estimated to range up to \$750,000.
