# INSTITUTE OF OCEAN SCIENCES, PATRICIA BAY

### Question No. 1,149-Mr. McKinnon:

- 1. Was a press release issued by Environment Canada indicating the estimated cost for the Institute of Ocean Sciences at Patricia Bay as 20 million dollars and, if so, for what reason does this figure differ from the 1974-75 Estimates total cost of \$10,750,000?
- 2. Has a decision been made to include additional organizations and, if so, what are they?

Mr. Len Marchand (Parliamentary Secretary to Minister of the Environment): 1. A press release was issued on December 10, 1974 the estimated cost for the Institute of Ocean Sciences at Patricia Bay, B.C., as \$20,000,000. The figure of \$10,750,000 in the 1974-75 estimates was based on a 1972 preliminary Task Force report. The wharf-marine facilities cost was estimated at \$1,936,000 and the buildings facilities at \$8,814,000. Consultant Design Architects were subsequently engaged and in April, 1974, the wharf-marine facilities design was completed, tenders called and Treasury Board approved an expenditure of \$4,200,000 for that purpose. The concept design for the building facilities was completed in May, 1974 and the estimated cost was

indicated as \$12,063,000 in 1974 dollars. However Treasury Board asked that escalation be applied to this estimate which resulted in an increase in the estimated building facility costs to \$16,198,685. With the addition of the wharf-marine facility cost of \$4,200,000 the total estimated cost of the complex is now \$20,398,685 with a 1978 completion date. This figure will be included in the 1975-76 estimates.

2. No decision has been made to include additional organizations at this time.

Have rigid operational procedures been issued for seaplane operations, landing and taking-off in the Port of Vancouver and, if so, would the Minister provide a copy of the regulations and, if such regulations cannot be made available, for what reason?

Hon. Jean Marchand (Minister of Transport): Special procedures are in effect at Vancouver Harbour which were promulgated in an Aviation Notice dated May 6, 1974.
