**Hon. Yvon Pinard (President of the Privy Council):** Madam Speaker, I wish to ask for unanimous consent, since we are about to start on private members' business, but perhaps I should explain. Although it is 5.15 p.m., I think it would be advisable, if Hon. Members agree, to keep at least one of the three hours set aside for private members' business. On this side of the House, there is consent for granting a full hour, that is, the first of the three hours provided for private members' business. I am asking the consent of the House for one full hour, but we are not prepared, however, to give consent for two additional hours, since it is already late. I also wish to inform our colleagues that there will be Royal Assent

at 5:45 p.m., and that the hour in question does not include the time required for royal assent.
