WHITE FARM EQUIPMENT COMPANY—SALE OF UNITED STATES ASSETS

Mr. Steven W. Langdon (Essex-Windsor): Mr. Speaker, on Tuesday the Minister of Regional Industrial Expansion said that the sale of White Farm's U.S. assets involves "no direct connection whatsoever with the Canadian company". Yesterday news reports revealed that amongst those items that are being sold in the United States is the tooling for parts used in Brantford, and that these will have to be bought, or replaced, to keep the Canadian company in production. Will the Minister admit that he misled the House? Will he also admit that the sale that I talked about on Tuesday is a serious threat to the future jobs of those people in Brantford?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, I am not sure to what news account the Hon. Member is referring. We are in touch with the Royal Bank and the receiver in this case, as well as the person who has been attempting to put together a financing package possibly to take over the White Farm Equipment concern. We have been assured that the activity in the United States has no effect as far as the ongoing operation or potential operation of White Farm in Canada is concerned. There was certainly no misleading of the House when I answered the Hon. Member's question earlier in the week.

Mr. Langdon: In fact it was *The Globe and Mail* of yesterday, Christopher Waddell, who pointed out that this is a key problem for the survival of this company.

REQUEST FOR ACTION TO HELP COMPANY

Mr. Steven W. Langdon (Essex-Windsor): Mr. Speaker, I ask the Minister again if he is prepared finally—having talked about socialist extraterritoriality, and trying to bring red herrings into this question—to act and get some urgency behind the survival of this company which is important not just for its own employees but for farm dealers across the country, and for the tool manufacturers, 13 of whom sent a telegram to him this week? Will he stop fiddling around and finally act?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, the Hon. Member has shed a lot of light on the source of his information when he refers to *The Globe and Mail*, and Mr. Waddell in particular.

We are acting with respect to his concern about White Farm, and we are in daily contact with various people who expressed an interest in reactivating the concern, including Mr. Sinclair, with whom we met and also discussed this matter on more than one occasion.

PREMIER'S TRIAL-INTERNAL INVESTIGATION

MacKay (Solicitor General of Canada): Mr. Speaker, the Member surely ought to know, if he would reflect upon the subject, that I speak with the Commissioner of the RCMP on many occasions, as he did when he was Minister. I can assure him, insofar as the request which was made to interview the Hon. Member for York South-Weston was concerned, that instead of co-operating with the force, as I am sure the former Minister would have done, he sought to make a media event out of it. Because of the circumstances, he never made a contribution to the review.
