### Eldorado Nuclear Limited

Public funds must be considered. Public ownership of Crown corporations places enormous demands on government resources to manage and financially support various enterprises, and it is taxpayers' money.

On a day to day basis accountability is not always focused as it should be. In addition, some Crown corporations cannot expect the infusion of the federal funds necessary to expand in the global economy.

If we use the example of Air Canada, it is difficult for the corporation to compete with private sector airlines without a great infusion of capital. If it does not get it from the private sector through investment, it will come out of the pockets of taxpayers.

Then the Minister dealt with management styles, as well as fairness and equity. Many Crown corporations compete directly with the private sector. In effect, some businesses have indicated, as was stated by the competitors of Air Canada and Eldorado, that they are competing against themselves. That is not fair and must be taken into consideration.

I think the evaluation process which must take place in connection with selling Crown corporations has been stated in an emphatic, positive, and straightforward manner by the Government.

Mr. Langdon: Madam Speaker, very briefly we have a national institution in the shape of Air Canada which was created to serve the vast transportation needs of a country which is unique in its size, unique in the diverse spread of its economic activities, and unique in its population.

It is very difficult to believe that a private sector operator will take on the difficult servicing of remote communities, the regular servicing of communities which need air service yet cannot provide the population base for such heavy servicing, such as the Hon. Member's own constituency of Sarnia—Lambton.

If the creation of a national institution made sense and was crucial in the past, if it could make money available in the past, not by taking it from government tax coffers but by the loans it was able to pay back to refurbish its fleet, why the sudden u-turn today? There is simply no national logic and certainly no logic suggested in that statement of a year ago.

# ELDORADO NUCLEAR LIMITED REORGANIZATION AND DIVESTITURE ACT

#### MEASURE TO ENACT
