PRIVATE BILLS

THE ROYAL COLLEGE OF DENTISTS OF CANADA—AUTHORITY TO PRINT COMMITTEE PROCEEDINGS

Hon. Salter A. Hayden, Chairman of the Standing Committee on Banking and Commerce, presented the following report of the committee on Bill S-44, to incorporate The Royal College of Dentists of Canada:

Your committee recommends that authority be granted for the printing of 800 copies in English and 300 copies in French of its proceedings on the said bill.

REPORT OF COMMITTEE ADOPTED

**Hon. Mr. Hayden,** Chairman of the Standing Committee on Banking and Commerce, reported that the committee had considered Bill S-44, to incorporate The Royal College of Dentists of Canada, and had directed that the bill be reported with the following amendment:

Page 4, line 13: Strike out "its business and affairs" and substitute therefor "the business and affairs of the College".

**The Hon. the Speaker:** Honourable senators, when shall this report be taken into consideration?

**Hon. Mr. Hayden:** With leave of the Senate, I move that this report be taken into consideration now.

Honourable senators, the amendment is a simple one and is for the purpose of clarification. Section 11 of the bill, which refers to the making of by-laws, provides authority

to make such by-laws as it may deem necessary; that is, this association, when it is incorporated, may pass by-laws for the government and management of its business and affairs. It was intended to apply to the government and management of the business and affairs of the college. The amendment makes that clarification; otherwise possibly "it" might be taken to refer back to "Council", which is used in the earlier sections of the bill.
