Section 241 of the Income Tax Act, the privacy provisions, precludes the Minister of Revenue from commenting on the specifics of any taxpayer or group. To do so would be a breach of taxpayer confidentiality. However, it should be noted that all advance tax rulings are conducted carefully to ensure compliance with the Income Tax Act.
