

HAS MANY SITES TO CHOOSE FROM

Travelers' Club Defers Selection of Site for Its Proposed New Home.

The special meeting of the Travelers' Club held on Saturday night at their club house, Richmond street, to receive the report of the committee appointed to select a site for their proposed new home, did not result as was anticipated in the final decision of the matter.

Since the meeting held the previous week it is understood a number of new propositions re property available were placed before the committee. Some of them more suitable than any heretofore considered, and as there seemed to be so many sites offered, any of which would meet all the requirements of the club, it was decided to refer the matter back to the committee, to report to a meeting of the members to be held on the evening of Saturday, June 1.

In the meantime the committee will make further search, the opinion of the members being that every effort should be made to secure an option on the best property available. It being generally admitted that in the interests of the club the new home, which will be modern and up-to-date in every respect, should be well in the heart of the city.

The membership of the club is increasing very fast, and the limit, which was at first limited to 125, has long since been exceeded reaching now about 200. The accommodation for members in the new home will be on such a scale that it is thought there will be no necessity to place any limit on the number of members from all parts of Canada and the United States who visit London are extended a cordial invitation to make the club house their home.

Those who have had the opportunity of being guests of the club's members have appreciated the courtesies extended, and some 25 or more of these out-of-town travelers from all parts have applied for enrollment as associate members, and have been accepted.

In the new club house it is proposed to furnish a number of bedrooms, and suites of rooms, so that the accommodations will be such that members who desire it can have in the club a home in every sense of the word.
