PRAYERS.

A Message was brought from the House of Assembly, by Mr. Whidden, with the following Bills:

A Bill, entitled, An Act to continue the Act to preserve and regulate the Navigation of the Harbor of Pugwash. Bill to preserve Harbor of Pugwash

A Bill, entitled, An Act to continue the Act in further addition to, and in amendment of, the Act for the choice of Town Officers and regulating of Townships, and the Act to alter and amend the same. Bill for the choice of Town Officers

A Bill, entitled, An Act to continue the Act in amendment of the Act, made and passed in the first and second years of His Majesty's Reign, entitled, An Act to extend the Laws and Ordinances of the Province of Nova-Scotia to the Island of Cape-Breton. Bill to extend Laws of Nova-Scotia to Cape-Breton

A Bill, entitled, An Act to continue the Act to lessen the expense of the proof of Written Documents in Actions depending in any of the Courts within this Province. Bill to lessen expense of proof of Written Documents

A Bill, entitled, An Act to continue the Act to preserve the Harbor of Cape Forchue, in Yarmouth. Bill to preserve Cape Forchue Harbor

A Bill, entitled, An Act to continue the Act to regulate the Pilotage of Vessels at the Port of Sydney, in the Island of Cape-Breton. Bill to regulate Pilotage at Sydney

The said Bills were severally read a first time.

Ordered, That the said several Bills be referred to Mr. Binney, Mr. McNab and Mr. Allison, to examine and report upon. Referred to Committee

A Bill, entitled, An Act to vacate the Seats of Members of the Assembly, in certain cases, was read a second time. Bill to vacate Seats of Members

On motion, *resolved*, that the further consideration of this Bill be deferred to this day three months. Deferred 3 months

A Bill, entitled, An Act relative to Executions Issuing from the Supreme Court of this Province, was read a second time. Bill relative to Executions

The House was adjourned during pleasure, and put into a Committee on Bills,—after some time the House was resumed, and Mr. Jeffery reported, that the Committee had made some progress, and had directed him to ask leave to sit again: which was granted. Committee on Bills Report progress

The Chairman also reported that the Committee had agreed to the following Bills, without any amendment.

A Bill, entitled, An Act relative to Executions issuing from the Supreme Court of this Province. Bill relative to Executions

A Bill, entitled, An Act to amend the Act to Incorporate a Marine Insurance Company in Halifax. Bill to Incorporate Marine Ins. Co.

The said Bills were then read a third time, and the question was put by the President on each Bill, Whether this Bill be agreed to?

It was resolved in the Affirmative. Agreed to

Ordered, That the Deputy-Clerk do carry the said Bills to the House of Assembly, and acquaint them therewith.

The Chairman also reported that the Committee had agreed to the Bill, entitled, An Act to Incorporate the Petit Plaister and Mills Company, with amendments. Bill to Incorporate Petit Plaister Co. Amended

The amendments were then read and agreed to.

Ordered, That the Deputy-Clerk do carry the said Bill and amendments to the House of Assembly, and desire their concurrence to the said amendments.

Mr. Cunard asked and obtained leave to present a Petition of William Pryor and others, relative to the Currency: which was read and ordered to lie on the Table. Petition of Wm. Pryor and others

Ordered, That the Bill, entitled, An Act concerning the Currency of Nova-Scotia, be the Order of the Day for to-morrow, to be read a second time. Bill concerning Currency Order of Day for to-morrow

The House adjourned until to-morrow, at one o'clock.
