Bill, intituled, "An Act to authorize the sale of certain lands belonging to the Estate "of the late Honorable *Peter Adamson*."

Bill, intituled, "An Act to amend the Charter of the *Quebec Fire Assurance Com-* "pany."

Bill, intituled, "An Act to incorporate the *Dresden Great Western Oil Company*."

Bill, intituled, "An Act to incorporate the *Roxton Mining Company*."

Bill, intituled, "An Act to erect the Township of *Wickham* into two separate "Municipalities."

Bill, intituled, "An Act to authorize the Town of *Stratford* to issue Debentures for "redeeming their outstanding Debentures."

Bill, intituled, "An Act to incorporate the *Crystal Lake Cemetery Company*."

Bill, intituled, "An Act to vest the Protestant Burial Ground at *Hudson*, in the "Incumbent and Churchwardens of *St. James' Church, Vaudreuil*."

Bill, intituled, "An Act to incorporate the Village of *New Edinburgh*, in the County "of *Carleton*."

Bill, intituled, "An Act to amend the Act to incorporate *L'Institut Canadien "Français de la Cité d'Ottawa*."

Bill, intituled, "An Act to amend the Act passed in the twenty-seventh and twenty- "eighth years of Her Majesty's Reign, respecting the granting of Charters of Incorporation "to Manufacturing, Mining and other Companies."
