Award-winning Program Reaches Out By Guillaume Parent

In 1985, a group of trade officers in Buffalo invited Canadian business representatives to the Consulate General to take part in New Exporters to Border States (NEBS), an intensive day-long session on how to do business south of the border.

Although the NEBS program is still running 25 years later, fewer companies are willing to travel to Buffalo for the training. This past summer, a team of officers in Ottawa and Buffalo took on the challenge of revamping the original course to better reach clients. The result is a webinar series that delivers targeted elements of NEBS using the Web.

The webinar series, now called ExportUSA webinars, has many advantages, and finds a new and wider audience while eliminating travel costs. Participants say it is an excellent way to provide valuable information to companies looking to enter the U.S. market.

Last December, the updated program won an inaugural Deputy Ministers' Award of Excellence in Transformation, recognized for aligning DFAIT with government priorities and improving services to Canadians.

INC Has Arrived

DFAIT has introduced a program to help Canadian businesses invest responsibly in developing countries. The \$20-million Investment Cooperation Program (INC) supports a range of activities that enhance the economic, environmental and social benefits of doing business abroad.

Dave Murphy, Director of the Investment Cooperation Program Division, says INC aims to reduce poverty by focusing on supporting the Canadian private sector in developing countries. Financed by Canada's international assistance envelope and cost-shared with Canadian businesses, the program was formerly the Canadian International Development Agency's Industrial Cooperation Program.

"While the program continues to pursue important development objectives," Murphy explains, "It has also been redesigned to better respond to the needs of the business community."
