the custom to do so. If there is nothing to the contrary I see no reason whatever for not acceding to the request.

SECONDARY MORTGAGE MARKET-INQUIRY AS TO SALES

SECONDARY MORTGAGE MARKET-REPLY TO REQUEST FOR INFORMATION AS TO REGULATIONS

Walker (Minister of Public Works): Yesterday the hon. member for Burnaby-Coquitlam asked a question about the intention of the government to acquaint members of parliament with the new regulations. In my statement to the house on April 17 dealing with the subject of the development of a secondary mortgage market, I stated that there remain several technical and procedural matters to be resolved. These matters are presently being worked on, and shortly it will be determined whether we will require regulations to be established by order in council or whether we can establish procedures within the framework of existing legislation and regulations. The house will be informed of the details when the various matters are resolved.

The answer to that question is that I have seen a press report dealing with this matter which may well be the one referred to by the hon, member in his question of April 12 addressed to the Acting Minister of Transport. There has, however, been no communication this year from the United States authorities regarding the formation of a joint Canada-U.S.A. committee to study the feasibility of deepening the Richelieu river.

PROPOSED U.S. TAX ON COMPANY PROFITS INVESTED ABROAD
