\*PROBLEMS OF EXCESSIVE DRINKING, N.W.T. Question No. 1,372—Mr. Rheaume:

1. Have any comprehensive studies been done by the federal government on the social and economic problems resulting from excessive drinking of alcoholic beverages in the N.W.T. and, if so, what studies were done, by whom, and what were the recommendations, if any?

2. Does the government have any program under way to alleviate or combat problems resulting from excessive drinking in the N.W.T. and (a) if so, what are these programs (b) if not, are there

any plans to initiate such programs?

Mr. Laing: 1. My department, through the northern co-ordination and research centre, has commissioned studies into the uses of alcoholic beverages in three settlements in the Northwest Territories. These studies are being carried out by Mr. Donald Clairmont, assistant professor of sociology, St. Mary's University, Halifax, N.S. and Dr. John J. Honigmann, professor of anthropology, University of North Carolina. The studies are still in progress, and the only preliminary report received to date contains no recommendations.

In addition the incidence of excessive drinking where this occurs, and special factors which may influence the problem, have been discussed in other sociological reports on northern communities commis-

sioned by the centre.

2. Federal participation in the study of this problem is occasioned by the federal concern for Eskimos. An interdepartmental committee has been at work for some time assembling information on the handling of comparable situations elsewhere in Canada, and assisting in co-ordinating the work of government and private agencies. However, liquor policy is the responsibility of the territorial council and government. As its votes and proceedings show, the council of the Northwest Territories has given extensive and continuing attention to the problem of excessive drinking and to policies to deal with it.
