*MEDICAL REHABILITATION CENTRE, VIET NAM

Question No. 141-Mr. Winkler:

- 1. Did the government of Canada request a study to be made in regard to the establishment of a Medical Rehabilitation Centre to care for civilians in Viet Nam and, if so (a) what are the names of the people who participated in this study (b) what was the content of the report (c) were the services of such a team of medical personnel made available to the government?
- 2. Does the government now intend proceeding with the establishment of such a centre, and if not, for what reason?
- Mr. D. S. Macdonald (Parliamentary Secretary to Secretary of State for External Affairs): 1. Yes. (a) Dr. Gustave Gingras; (b) An outline of the type of rehabilitation centre which might usefully be established and its requirements in respect to personnel, materials, and equipment; (c) If arrangements for this project can be concluded with the Vietnamese authorities, it is expected that the required personnel can be recruited.
- 2. The second part of the question has been answered in the answer to subpart (c) of the first part.

Questions

Hon. Judy V. LaMarsh (Secretary of State): 1. No one was employed by or with the authority of the representation commissioner to assist the various electoral boundaries commissions in the work of redistribution. Whenever requests were made by a commission for the services of any member of the staff of the representation commissioner, the services of such member were made available to that commission. Mr. A. J. Lineger was employed as a supervisor by the representation commissioner on December 23, 1963, to assist him in the work of redistribution. At the request of the electoral boundaries commission for Ontario, the services of Mr. Lineger, whenever required, were made available to such commission.

2. Mr. A. J. Lineger, age 55; education: high school and one year university. Employed from July, 1928 to August, 1961, on the staff of the Coca-Cola Company Limited of Ottawa, except for service in the Canadian army from July, 1942 until March, 1946, when discharged with the rank of sergeant in the Royal Canadian Ordnance Corps. Employed from April 26, 1962 to December 22, 1963, on the staff of the chief electoral officer as supervising clerk, and from December 23, 1963, to date, on the staff of the representation commissioner. During his period of employment in the chief electoral office, Mr. Lineger demonstrated to the chief electoral officer that he possessed the qualities and ability to fill the position of a supervisor in the representation commissioner's office. Mr. Lineger, as in the case of all members of the staff, acquired knowledge of the work of the new method of redistribution while on the job.
