## \*IMMIGRATION ACT

Is it the intention of the government to present to Parliament at this Session, a new Immigration Act or amendments to the existing Act based on the White Paper on Immigration and the recommendations of the Joint Committee of the Senate and House of Commons on Immigration?

**Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council):** Mr. Speaker, while the Immigration Act is under review, there are no plans at present to introduce revisions to the present act during this session. The government has already implemented many of the recommendations of the white paper on immigration through revisions to the immigration regulations and administrative procedures.

STATUS OF REFUGEES

1. Has Canada acceded to the 1951 International Convention on the Status of Refugees?
2. Has the Canadian Government made any decision on the establishment of a refugee eligibility referred to in paragraph 55 of the White Paper on Immigration, October, 1966?

**Hon. Allan J. MacEachen (Minister of Manpower and Immigration):** 1. Yes.
