Hon. John N. Turner (Minister of Finance): It would not be appropriate to make any suggestions to Canadian banks in this matter over which the Minister of Finance has no jurisdiction. It is believed that Canadian banks have taken steps to supplement the pensions paid to former bank employees who have been retired for a considerable period of years.
