CANADA PENSION PLAN

DELAY IN PROCESSING CLAIMS—GOVERNMENT ACTION

Mr. Robert Muir (Cape Breton-The Sydneys): Mr. Speaker, my question is directed to the Minister of National Health and Welfare. Since it has taken between four and six months and in some cases up to eight months to process claims under the Canada Pension Plan, would the minister be good enough to have that situation investigated and ascertain if further equipment is required such as computers, or more staff, in order to expedite these claims?

Hon. John C. Munro (Minister of National Health and Welfare): Mr. Speaker, I would advise the hon. member that, because of the hundreds of thousands of claims now coming in as the program ages, it has been necessary in order to catch up with the load for us to do the very thing the hon. member is suggesting. We are converting to computers but the process is not complete.

EXTERNAL AFFAIRS

INDIA—CANADIAN ASSISTANCE FOLLOWING TIDAL WAVE

Mr. Heath Macquarrie (Hillsborough): Mr. Speaker, may I ask the Secretary of State for External Affairs if the government has now arranged a program of special assistance for the victims of the terrible tragedy in the state of Orissa, India. If so, what is the nature of the assistance?

TESTING OF MORNING AFTER CONTRACEPTIVE PILL

Mr. Doug Rowland (Selkirk): Mr. Speaker, my question is to the Minister of National Health and Welfare. Is he aware that an American research laboratory in Chicago has conducted successful experiments with the morning after contraceptive pill, and is the minister's department prepared to conduct similar tests on this pill to determine whether or not it is suitable for use in Canada?

Hon. John C. Munro (Minister of National Health and Welfare): Mr. Speaker, the answer to that, generally, is yes. We are watching the developments in this area closely. Our most recent action was to reconstitute the experimental committee on the pill and other recent discoveries in this area. We expect to have a report from them shortly.
