- 2. Personal History Forms are required for the initial clearance. They expire at the end of 5 years at which time employees are required to complete new ones.
- 3. Fingerprinting is a mandatory requirement of the security clearance process. Employees are normally fingerprinted on entry into Government Service, however, they may be required to be fingerprinted a second time in instances when records have been misplaced.
- 4. The R.C.M.P. Branch of the Solicitor General's Department has access to security documents. In this Department, access is restricted to the Chief of Security Services.
- 5. The estimated cost to the Royal Canadian Mounted Police is \$15.96 for each security clearance. As we do not have the number of security clearances requested by the Department of National Revenue, we are unable to provide the total cost.

VANCOUVER INTERNATIONAL AIRPORT—BAGGAGE SECURITY

Question No. 3,169-Mr. Reynolds:

- 1. For what reason was a security system set up at the baggage counters for incoming passengers at Vancouver International Airport?
- 2. (a) Did the system cost in excess of \$75,000 and, if not, what was the cost (b) is Air Canada's share 50 per cent?
- 3. For what reason was this system installed when in the year 1974 there were only twenty-six incidents of loss and theft reported at the Airport, which under the present regulations would only cost the airlines \$5,200?
- Hon. Otto E. Lang (Minister of Transport): 1. At request of airlines to prevent theft and the possibility of unintentional passenger error in claiming baggage.
- 2. (a) No. The cost was \$30,360. (b) No. The installation was funded by Transport Canada. The Airlines pay for security personnel on the basis of numbers of arriving passengers.
- 3. Airline experience has been that losses have been greatly reduced since implementation of the system in 1974. Present regulations limit airline liability to \$500 for any one piece of lost baggage.

NEWFOUNDLAND—FISH PROCESSING PLANTS APPLICATIONS

Question No. 3,172-Mr. Marshall:

Have any applications been received from fish processing plants in the Province of Newfoundland under the Accelerated Capital Cost Allowance Programme to take advantage of the two year write-off programme and, if so, what are the names of the plants who have applied since the inception of the programme?

Mr. George Baker (Parliamentary Secretary to Minister of the Environment and Minister of Fisheries): No such applications have been received from fish processing plants in the Province of Newfoundland.

- Mr. George Baker (Parliamentary Secretary to Minister of the Environment): 1. Yes. Eleven such applications have been received from Newfoundland.
- 2. Publicity for this program has not been directed towards any particular sector of the economy. All polluters and/or potential polluters are included and considered for eligibility under the regulations.
