DATE OF DECISION ON ADMISSION OF PALESTINIAN LIBERATION ORGANIZATION REPRESENTATIVES TO ATTEND TORONTO CONFERENCE

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I have a question for the Prime Minister. As he seemed to reach his usual low boiling point rather early today, I suggest that he should not blow his top, because it is bad for his health.

Mr. Hees: My question is this: as the government has now had an additional week, on top of many previous weeks, to discuss whether it intends to allow the PLO, an organization whose mode of operation is based on organized terror and murder, to come to Canada for the United Nations conference in September, has the government made up its mind on what its decision is to be on this matter and, if so, will the Prime Minister announce it to the House now?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I point out that the hon. member blew his top a long while ago; that will explain why he has none.

Mr. Hees: It is time to adjourn parliament.

Mr. Trudeau: Mr. Speaker, I withdraw that. I really should not talk that way to a senior citizen, although he is in such good shape that I keep forgetting he is over 65.

Some hon. Members: Hear, hear!

Mr. Trudeau: Mr. Speaker, on the substance of the question, as opposed to the preamble, I would say that my commitment still stands. We will make an announcement on this next week.

Mr. Hees: A supplementary question, Mr. Speaker. The Prime Minister referred to my distinguished age. I suggest that if he does not cool it a little more than he has in the past, he will not make it.

My question is this: Is it not a fact that the government has already made its decision on this matter but has decided to hold up the announcement until next week, in the hope that parliament will then be recessed, so that the government can avoid the anger of the opposition which the Prime Minister's announcement will provoke?

Mr. Trudeau: No, Mr. Speaker. If it is held up until next week, it is in the hope that a few more Conservatives show up to sit on their benches.
