PROPOSED ADOPTION OF MEASURES TO INCREASE LEVEL OF INCOME OF FISHERMEN—MOTION UNDER S.O. 43

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, I rise under the provisions of Standing Order 43 to raise a matter of urgent and pressing necessity.

In view of the announcement that the prices for freshwater fish are to be at the same depressed level as in 1973, in view of the minister's failure to comply with a request for representation on the board in line with production in certain areas, in view of the failure of the Freshwater Fish Marketing Corporation to provide adequate markets—to the point at which very low and in some cases no prices are quoted for certain species—resulting in many lifelong fishermen having to resort to welfare, I move, seconded by the hon. member for Dauphin (Mr. Ritchie):

That the Minister of State (Fisheries) be immediately seized with this problem, to propose effective measures to maintain levels of disposable income for freshwater fishermen at an increased level which would take into account increased costs of production.

REQUEST FOR ASSURANCE AIR TRAFFIC CONTROLLERS WORKING—ASSURANCE TO PILOTS OF SAFE FLYING CONDITIONS

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, my question is addressed to the Minister of Transport to whom we extend sincere condolences. At 5.30 yesterday afternoon an official in the hon. gentleman's ministry stated that air traffic control operations were back to normal at all airports across the country. I am advised that this is the situation which prevails as of now. Can the minister confirm that this is the case and, in the light of the position taken by CALPA can he tell us what assurances, if any, have been given to the airline pilots so that the services can be normalized?

Hon. Otto E. Lang (Minister of Transport): Again today we have indications that the air traffic controllers are working throughout the country. Conditions, therefore, are normal for the flight of aircraft. There seems to be no reason whatever for pilots not to fly. International flights are, indeed, flying through Canadian airspace and using Canadian airports. It is my hope that other pilots in Canada will do the same and that the inconvenience to the travelling public will end.
