member for Scarborough—Rouge River and the acting Privacy Commissioner. The committee also sought opinions from the Law Clerk, from Parliamentary Counsel's Office and from three distinguished experts.

After careful examination, the committee recommends that the House adopt an order requiring the Solicitor General to provide to the Justice Committee, within 30 days, the unexpurgated versions of the report by Mr. Weir governing the escape by David Gingras and the report by the Board of Investigations concerning an offender, all pursuant to section 8(2)(C) of the Privacy Act, section 18 of the Constitution Act, 1867, section 4 of the Parliament of Canada Act and section 108(1) of the Standing Orders.

I would also state briefly that I wish to compliment the member for Scarborough—Rouge River for his detailed and important work regarding the supremacy of Parliament, which is important to all of us. Although I sit opposite from him, I compliment him on his work.
