In the matter of the estate of Louise M. Holly, personally \$1,050, Mrs. Alice E. Holly was sworn as administratrix. C. R. Sanford was proctor. Mrs. Alice Holly was also sworn as administratrix of the estate of Alexander B. Holly, relict of \$600, and personally \$12,600.

Margaret M. Darnes was granted administration of the estate of Katherine Deane, personally \$1,900, G. H. V. Belyea, K. C., was proctor.

The last will of Eliza D. Howard was proved, relict of \$1,300 and personally \$3,400, and letters testamentary issued to N. P. MacLeod and C. B. Lockhart, K. A. Wilson was proctor. Aside from family bequests she left \$200 to the trustees of Charlotte Street Baptist church.

Letters of administration were granted to Amy E. Silliphant in the matter of the estate of James Flagg, personally \$3,078.24, F. Kerr was proctor.

Amie K. Hutchings, G. A. Henderson and J. W. Cassidy were sworn as executors under the will of Charles H. Hutchings, personally \$11,153. Among the bequests which were made in the family was one of \$500 to the Missionary Society of the Methodist church of Canada.

The last will of John P. Macintyre, was proved and letters issued to A. P. and R. A. Macintyre and G. W. Ketchum as executors. He left \$3,550 real and \$33,424.46 personal estate, divided among members of the family. C. H. Ferguson was proctor.

Jonas Grundmark was sworn as executor under the will of Hannah A. Grundmark, relict of \$2,400, S. W. Palmer was proctor.

Out For Water; Landed In The Police Station

A new version of how a man from the North End found himself in the Police Court, charged with drunkenness, came to light this morning. When asked what he was doing out between eleven and twelve o'clock last night, he said: "I went out to get a drink of water."

"You went out of your own house to get a drink of water," interjected the magistrate, "but I suppose you met that nice, kind fellow who gave you a drink of rum instead. Portland seems to be full of them. That's a new one. 'A drink of water.' Take him to the guard room, Sergeant."

Grant Injunction Against Sale Of Neve Property

Matter Up in Circuit Court Today, But Defendant Still Absent—Case Over Until June 22.

In the circuit court this morning the matter of F. B. McCurdy C. vs. Dr. F. H. Neve was heard, argument of counsel occupying most of the session. An injunction was granted by Chief Justice McKewen against the sale or disposition of the property in Dorchester St. lately occupied by the defendant and standing registered in the name of his wife. The contention of the plaintiff company is that the property was purchased with funds supplied by the defendant and placed in the name of his wife. The question of consideration will be heard further. The defendant physician was not in court this morning. He has not returned since the visit of Sheriff Wilton to his home some days ago with a capias for his arrest. He took his automobile with him and is said to be now in the United States. The claim in this action is for about \$30,000 alleged to be due for transactions in stocks, J. F. H. Teed appears for the plaintiff and B. L. Gerovoy for the defendant. The case will be heard again on June 22nd.

Work Situation In N. S. Improves

Halifax, N. S., June 8.—In the monthly report issued by the Employment Service of Canada of its activities in Nova Scotia during May, it is shown that there is a great decrease in unemployment compared with the same period a year ago. Last May the service assisted in placing seven hundred and thirty applicants and at the end of the month had twenty-five hundred registered as out of work. At the end of May this year thirteen hundred had been placed and only nine hundred and sixty-seven remained unemployed.

THREE FINED FOR SPEEDING

Provincial Constable Crawford caught three speeders on Rothery avenue last night and brought them before Magistrate Allingham today. Two were allowed to go by paying a fine of \$5 and costs, while the third, who was also charged with reckless driving, was fined \$20. Fredericton, June 8.—The public closing exercises of the Provincial Normal School were held this morning and attracted a large crowd. His Honor the Lieutenant Governor presided and seated on the platform with him were Principal H. V. Bridges, L. L. D., Dr. W. S. Capper, Chief Superintendent of Education, and others. The musical portion of the exercises were particularly noticeable the instructor in music, W. J. Smith, A. R. C. O., having prepared some elaborate numbers in which the students acquitted themselves well. Throughout the exercises a prominent part was taken by students from St. John and vicinity. A quartette of violinists took a prominent part in the proceedings. It was composed of Miss Marion A. Marven, J. Amos Allen, Miss Jessie Craie, and Miss Helen M. Foley.

After the opening march and opening exercises a review of the year's work was given by Principal Bridges who referred to the facts that the year had seen the largest attendance in the history of the school, the largest number qualifying for entrance and the largest number taking the course leading to the Class I license.

A chorus for male voices followed, after which Miss Jean Sewell, of St. John gave a lesson in literature to a class from grade VI of the model school. After a reading by Miss Muriel Mahoney of West St. John, Miss Muriel Hawker of St. John and Miss Helen Gough of Hillsboro were heard in a duet. A lesson in reading to a class from grade I of the model school followed. Miss Freda McParlane of East St. John being the teacher.

The demonstration in physical training was given under the direction of Ralph March of Hampton and Miss Grace Parkinson of St. John. Miss Alexena LeBlanc of Cape Bald gave a French reading. A solo and a chorus, with John Linton of Fairville as soloist, was greatly appreciated. Miss Muriel Amos of Moncton gave a lesson in singing to a class from Grade II, and Miss Helena Hancey of Deer Island gave a reading.

The most elaborate musical number in the programme was "O Hear My Prayer," by Mendelssohn, which was greatly appreciated by the large number of visitors. Miss Helen Gough of Hillsboro was soprano soloist. Others taking part were Miss Mary F. Crozier and Miss Muriel L. Hawker of St. John, Ralph E. March of Hampton, K. 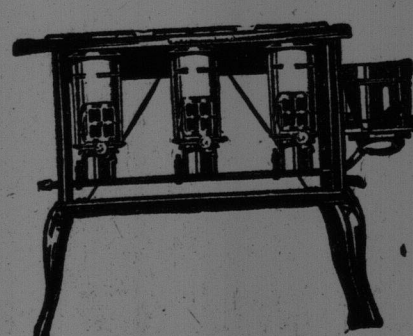
The mackerel drifters are starting operations this week. A few of the Caraqueet cod fishers are reported to have had very good returns during the past week.

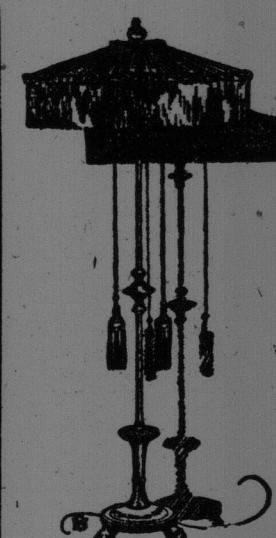
