"COMMON CLAY" POWERFUL PICTURE

Imperial Crowded Yesterday When the Great Harvard Prize-Play Was Shown.

It is estimated that "Common Clay," the Harvard prize play by Cleve Kinkaid, which is now being shown at the Imperial and in which Jane Cowl achieved one of her most notable successes, has been witnessed by more than five million persons. Under the direction of A. H. Woods, it ran for a full year at a Broadway attraction, playing to the capacity of the house. During the three years following it was interpreted by six companies throughout the United States and Canada and everywhere attracted large audiences. Now that A. H. Woods has produced a screen version of this masterpiece, it is figured roughly that, in all, about ten or twelve million persons will watch it on the silver screen. DEATH OF NURSE.

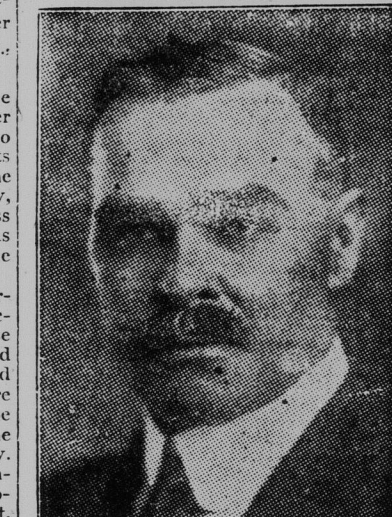
(Frederickton, N. B.)
The death occurred at the Red Cross Convalescent Hospital, Washington, recently, of Miss Anna B. West, daughter of E. L. West, of Centerville, N. B., aged thirty-four years.

Miss West was a graduate of the Provincial Normal School and after teaching school for two years went to Boston and entered the Massachusetts General Hospital. After graduating she followed her profession until February, 1917, when she enlisted as a Red Cross nurse and sailed for France. She was in Belgium for some time, serving at the front.

After the armistice she went to Germany with the American Army of Occupation and while serving as a nurse was stricken with meningitis. She rallied sufficiently to be brought to the United States and taken to Washington, where everything possible was done, but the complications which set in baffled the best medical skill and she passed away. The deceased is survived by her father, E. L. West, of Centerville, a step-mother, one sister, Miss Frances West, superintendent of one of the departments of the Massachusetts General Hospital, and one brother, Charles F., of

the Star-Herald Publishing Company, Presque Isle. The body will be brought to Centerville for interment.

Bearing interest from November 1st, 1919, and offered in two maturities, the choice of which is optional with the subscriber as follows:

5 year Bonds due November 1st, 1924
15 year Bonds due November 1st, 1934

Principal payable without charge at the Office of the Minister of Finance and Receiver General at Ottawa, or at the Office of the Assistant Receiver General at Halifax, St. John, Charlottetown, Montreal, Toronto, Winnipeg, Regina, Calgary and Victoria.

Bonds may be registered as to principal or as to principal and interest, as hereinafter provided, at any of the above-mentioned offices.

Interest payable, without charge, half-yearly, May 1st and November 1st, at any branch in Canada of any Chartered Bank.

Principal and Interest payable in Gold
Denominations: \$50, \$100, \$500 and \$1,000

Issue Price: 100 and Accrued Interest, Income Return 5 1/2% per Annum

The proceeds of the Loan will be used to pay indebtedness incurred, and to meet expenditures to be made in connection with demobilization (including the authorized war service gratuity to our soldiers, land settlement loans, and other purposes connected with their re-establishment into civil life), for capital outlay upon shipbuilding, and other national undertakings forming part of Canada's industrial reconstruction programme, and for the establishment of any necessary credits for the purchase of grain, foodstuffs, timber and other products, and will be spent wholly in Canada.

Fully registered bonds, the interest on which is paid direct to the owner by Government cheque, will be issued in denominations of \$500, \$1,000, \$5,000, \$10,000, \$25,000, \$50,000, \$100,000, or any multiple of \$100,000.

Payment of Interest

A full half-year's interest at the rate of 5 1/2% per annum will be paid May 1st, 1920.

Form of Bond and Delivery

Subscribers must indicate on their applications the form of bond and the denominations required, and the securities so indicated will be delivered by the bank upon payment of subscriptions in full.

Bearer bonds of this issue will be available for delivery at the time of application to subscribers desirous of making payment in full. Bonds registered as to principal only, or fully registered as to principal and interest, will be delivered to subscribers making payment in full, as soon as the required registration can be made.

Payment of all instalments must be made at the bank originally named by the subscriber.
