

And the Question being again proposed, That the Bill be now read the third time;

Mr. *Stephenson* moved, in amendment, seconded by Mr. *Wallace* (Norfolk), That all the words after "now" to the end of the Question, be left out, and the words "recommended to a Committee of the whole House, with an instruction that they have power to amend the third clause by adding the following words: 'Provided that any party who, for the purpose of settling his claims against said Company for 'working expenses,' has received bond or bonds of said Company, and is still the owner of such bond or bonds, shall be considered and treated in the same manner as if the Company had not settled such claim by the issue of such bonds, and the amount of such bond or bonds shall be considered and treated as a debt incurred and held by the said Company on the 12th day of March, 1878, as provided by said section,' inserted instead thereof;

And the Question being put on the Amendment; the House divided; and the names being called for, they were taken down, as follow:
