Sec. 4.—No player shall be allowed to jump at or shoulder an opponent from the side or from behind, while the runner is after or reaching the ball. Sec. 5.—Player shall be allowed to wrestle with legs outstretched, so as to throw an opponent. Sec. 6.—Body checking is strictly prohibited, except a dodger in possession of the ball, and must be done from the side. Sec. 7.—A player shall be allowed to check the goal keeper's cross while he has the ball. Sec. 8.—A player shall be allowed to strike another with his cross or otherwise, shall be immediately ruled out of the match.

ARTICLE 5.—After last sentence of this article so as to read as follows: "The referee is allowed to have one vote for each delegate to whom they are entitled, representative of the full number of delegates, each delegate shall have one vote, and the delegates of clubs representing them shall be allowed to cast the full number of votes to which their club is entitled."

By Mr. Angus Grant of the Montreal club: "That the present condition under which the larceny championship is held is not a creditable one, and towards that the Montreal club is desirous of making a change in the present mode of holding the championship, and that the present larceny championship be held from Nov. 1 to one year, to October of the following year by the club winning the majority of a series of games, and that the season between a certain number of clubs who should be invited to participate, and that the present laws governing the championship be altered to provide for the change."

The most important is that of which notice is given by Mr. Angus Grant, of the Montreal club, to change the present mode of championship matches by awarding the title and pennant to the club winning the majority of a series of games between recognized first-class clubs. This is a proposition that requires serious consideration and will doubtless receive it. At first blush the probability seems that it will find little favor, as having a tendency to bring the game down to the dead level of football, cricket, or tennis. It is not surprising to us like baseball to our neighbors. Over the way there are at least eight high class baseball clubs to every single first-class larceny organization in this city.
