## Speaker's rulings and statements:

Amendment to bill on motion for second reading:

- 1. On a point of order that an amendment was not relevant to provision of bill, the amendment was allowed to stand since it was declaratory of principle contrary to principle of bill, 326.
- 2. Amendment concerning provision of hearings for public servants not relevant to principle of supply bill, 374.
- 3. Doubt expressed as to propriety of an amendment which would defer second reading but did not oppose principle of bill, amendment allowed to stand, 465.
- 4. Amendment, although it may in effect be direct negative, is in order when it is declaratory of a principle contrary to principle of bill, 535.
- 5. Amendment ruled out of order in that it introduced subject-matter not covered by provision of bill, 537-9.
- 6. Amendment declaratory of a principle which is opposed to but relevant to principle of bill, in order, 539.
