H. F. S. PAISLEY

Mr. HANSON:

1. Has H. F. S. Paisley, editor of the Sydney, Nova Scotia, Record, been appointed publicity agent for the Department of Marine and Fisheries?

1. Mr. Paisley, who was editor of the Sydney Record, was appointed director of publicity in the fisheries branch.

2. His notification of appointment from the Civil Service Commission was dated January 23rd, 1929. He reported for duty on February 27th, 1929. \$3,420 per annum. To gather and disseminate information regarding the production of fish, market conditions, etc.; to direct the collection and analysis of all fisheries statistics; to investigate transportation facilities for fish; to prepare and edit fisheries publicity material and related work.
